DSO Decision: Winning Answers from Every Angle

In the dental profession today, many conversations broach the topic of DSOs. There is a lot of information out there, both true and false. There also is a great deal of confusion about what DSOs really do and how they operate. This session provides insight for anyone who is thinking of selling their practice to a DSO, partnering with a DSO, starting a DSO, working for a DSO, or just looking for a better understanding of how DSOs operate and impact the profession. This session also will cover effective strategies to compete with DSOs for those in the quest for the preservation of the private practice of dentistry.

- Examine how to prepare a dental practice for sale to a DSO and effectively negotiate a DSO transaction.
- Develop, explain, and effectively negotiate an employment agreement with a private-equity-backed DSO.
